Do solar panels get a final affirmative decision?

For these and other reasons, the overwhelming majority of filed AD and CVD cases end up with final affirmative determinations, generally at high margins. The same is likely to occur for solar panels as well, just as occurred with the earlier filing against Chinese solar panels.

Are Chinese PV products dumping?

Subsequently, in May 2012, the US Department of Commerce ruled that Chinese PV products had dumping behaviors, with dumping margins ranging from 18.32 % to 249.96 %, and began to impose antidumping duties.
