What should I do if my solar panels are damaged?

Regularly inspect your solar panels for damage. Keep tree and bush branches away from your solar panels. Doing so may mean pruning trees and bushes or removing them if they become too large. Regularly clean your panels or have a professional service perform the task.

How do I know if my solar panels are damaged?

Consider Equipping Your Home With Solar Panels There are a few ways to detect damage to your solar panels. A visual inspection may reveal broken or cracked glass, a problem with the frame or mounting or damaged or disconnected wiring issues. Your power inverter may also produce an error message if it's designed to do so.

Should I fix a broken solar panel?

Choosing not to fix a broken solar panel in your system is sometimes an option. However, remember that many homeowner's insurance policies and some warranties cover certain types of damages to solar panels. Following up on repairing or replacing broken parts may be in your best interest.

What is the difference between removal and reinstalling solar panels?

Removal is the process of temporarily removing solar panels or the entire system from your home. Reinstallation is the process of reinstalling solar panels after reroofing, remodeling or relocation.
