How does a solar PV O& M contract work?

o Asset Management Agreement A common contractual framework for solar PV O& M is the "fixed price" model for a specified scope of work that can include administrative, operational, and Preventive Maintenance tasks. A "cost plus" element can then be added for Corrective Maintenance or additional services.

How much LDS should be capped in open solar contracts O& M?

o The amount of yearly LDs should be capped at 100% of the O& M annual fee. Reaching this cap usually results in termination rights for the Asset Owner and the O& M service provider. In the Open Solar Contracts O& M template, the right is only given to the Asset Owner Service standards

How to ensure solar PV power plant security?

Therefore, solar PV power plant security should be ensured by specialised security service providers, directly contracted by the Asset Owner or, exceptionally, subcontracted by the O& M service provider. The security service provider should also assume liability for the services provided.

What is the solar energy standardisation initiative (SESI)?

Formerly known as the Global Solar Energy Standardisation Initiative (SESI) this is a joint effort of the Terrawatt Initiative and the International Renewable Energy Agency (IRENA). SolarPower Europe contributed to the drafting of the template O& M contract.
